


MAIN CATEGORIES OF LEGAL ISSUES*







TYPES OF GOODS DISTRIBUTED TO BENEFICIARIES










MOBILE GROUPS VISITS BY REGION












MHPSS FIELD TRENDS

- Due to chronic stress, there are more frequent cases of societal polarization. The level of emotional tension in communities between different population groups is increasing: IDPs, local residents, returnees, veterans, military families. Providing humanitarian assistance "only for IDPs" contributes to this tension.
- There is an increased demand for support and strengthening the capacity of communities: developing communication algorithms with vulnerable population categories, options for integration measures for veterans and military families, burnout of first-line state structure providers.
- The relevance of individual counselling remains all over Ukraine, including the western and northern regions, which may be perceived as safer ones.

MAY - AUGUST 2023: ECONOMIC RESILIENCE AND EARLY RECOVERY

In May 2023, R2P launched a new programme aimed to support early recovery and development of economic activity, resilience and self-sufficiency of vulnerable populations. As of late August, two projects are running dealing with employment challenges of IDPs and supporting micro entrepreneurship for war affected population.


Research:

To ensure data-driven decisions and support, R2P conducted 2 surveys:

- IDPs regarding employment issues and needs (13 oblasts);
- Entrepreneurs regarding staff needs, on-site training capacity and intentions (9 oblasts).

R2P actively participates in Livelihoods Technical Working Group and Durable Solutions Work Group working groups to contribute to proper response to the needs of IDPs and conflict-affected populations. R2P submitted suggestions to United Nations in Ukraine Transitional Framework via Durable Solutions Work Group.



- On the housing assistance for IDPs focusing on improving the mechanism of granting the housing assistance to IDPs;
- On ensuring access to pensions and other social payments for the conflict-affected population;
- Expert Council under the Representative of the Ukrainian Parliament Commissioner on the Rights of Citizens, Affected by the Armed Aggression against Ukraine;
- Coordination Headquarters for Ensuring the Rights and Freedoms of the Internally Displaced Persons.

JANUARY – AUGUST 2023: ADVOCACY

OTHER IMPORTANT EVENTS

- In March, R2P held an Expert Discussion on Restoring the Title Documents in Absence of Evidence discussing the issues of restoring title document for the purposes of participation in the new compensation mechanism for the damaged/destroyed properties.
- In April, R2P's Advocacy Coordinator participated in a working session organized by the European Council on Refugees and Exiles (Brussels) calling the European Commission and the EU Member-States to, inter alia, unify the approaches to the movements of the Ukrainians to/from Ukraine under the Temporary Protection Directive.
- In April, R2P attended the Round Table "What comes after the temporary protection framework? An overview and discussion of various option" (Brussels) discussing the necessity to ensure safe, voluntary, and well-informed return of the Ukrainians affected by war from abroad.
- On May 30, R2P organized and held the Housing Issues Workshop at the Civil Society Forum "Outlines of the Future: Victory, Recovery and Modernization of Ukraine" focusing on the issues of the temporary housing stock formation, collective centres and the new compensation procedure.
- In June, R2P took part in a Round Table Discussion "Safeguarding the Rights of Ukrainian Children Affected by War, Forced Displacement, and Emigration" (Brussels) highlighting a number of critical challenges in the field of the children's rights protection due to the military aggression against Ukraine.
- On June 19-21, R2P's President Oleksandr Galkin participated in the Development Assistance Committee Civil Society Days held by Organisation for Economic Co-operation and Development (Paris) as a key speaker in the panel discussion on the progress and challenges towards enabling civil society for a locally led transformation and balancing partnerships.

INTERVIEWS AND PODCASTS

- July: R2P took part in recording the 3rd episode of Advocating for Protection Podcast of the Global Protection Cluster's Advocacy Working Group. R2P emphasized the urgent need for a transparent and just compensation procedure, including for the casualties suffered by the civilians, and the administrative procedure for the registration of the civil status acts that took place on the temporarily occupied territories.
- July-Aug: R2P's experts gave a number of comments on various IDPs' rights related matters to Suspilne Novyny, TV Channel Espreso, Radio Svoboda, 4tv gorodok, etc.

JANUARY - AUGUST 2023: DISASTER RISK REDUCTION

4 COMPLETED PROJECTS AIMED AT:

- Strengthening the level of civil protection and the readiness of communities and institutions of the social sphere for emergencies;
- Raising awareness of communities and institutions of the social sphere regarding protection mainstreaming during emergencies;
- Raising awareness of the problems caused to Ukraine's environment as a result of the full-scale invasion (in particular, damage to water resources)
- Recovery of communities, in particular those affected by a fullscale invasion, according to the principle of 'Build Back Better';

NEW PROJECTS

2 NEW PROJECTS LAUNCHED, AIMED AT:

 Conducting an analytical study devoted to civil protection in the conditions of reforming the institutional care system in Ukraine. The main focus is on the analysis of the suitability of shelters in educational institutions for children with special educational needs from the perspective of post-war recovery.

Geography - Dnipropetrovska, Kirovohradska (new), Poltavska oblasts.

 Legal support of communities (new direction within the DRR Program) regarding the protection of the right to environmental safety and other environmental rights and interests. The focus is on strengthening the capacity of communities to record and assess the environmental damage caused by a full-scale invasion.

Geography - Chernihivska oblast (new).

JANUARY - AUGUST 2023: STRENGTHENING OF RESILIENCE AND COHESION IN UKRAINE

EVENTS ATTENDED BY R2P

- Social Cohesion program coordinator, Natalia Proskurenko, took part in an international
 webinar where the concepts and approaches of proactive protection were discussed, which
 was organized by the Global Protection Cluster. During the event, the risks of conflicts, as well
 as methods of supporting citizens suffering from problems caused by the war, were considered
 and analyzed. Specific examples from Ukraine, Colombia, Afghanistan and South Sudan were
 presented. (16 March, online).
- Civil Society Forum OUTLINES OF THE FUTURE: VICTORY, RECOVERY AND MODERNIZATION OF UKRAINE. The Forum aimed to unite and coordinate civil society to create a joint action plan for our Victory and Recovery. R2P talked about the challenges that exist for social cohesion in Ukrainian communities and what to do to strengthen it.(30 May, Kyiv).
- Fellows of Salzburg Global Seminar gathered for a meeting of Ukraine Civil Society Forum. At
 the meeting, several working groups set out priorities for the country, including concrete
 recommendations for stakeholders to support the rights, return, and reintegration of displaced
 persons and refugees, addressing both immediate humanitarian needs and long-term
 perspectives including the ultimate physical reconstruction and social integration of liberated
 territories as part of a Ukraine-wide project of national identity. (04-08 June, Salzburg, Austria).

R2P organized the conference "Ukrainian Approaches to a Just and Lasting Peace". The
event brought together representatives of Ukrainian civil society as well as members of
international organizations working in the field of peacebuilding. Participants presented the
results of peacebuilding projects and initiatives implemented at different levels and explored

JANUARY - AUGUST 2023: STRENGTHENING OF RESILIENCE AND COHESION IN UKRAINE

ANTI-STIGMA CAMPAIGN

Our main idea was to raise the issue of stigmatization of internally displaced persons (IDPs). Despite the large mobilization resources of society, conflict situations may arise involving IDPs and representatives of host communities.

The main component was our video, with the help of which we were reaching out to IDPs and host communities to remind them that only by coming together can we survive these difficult times. And the IDPs are in fact, a symbol of unity.



ACTIVITIES

Research:

• In June 2023, research project "Statelessness in Ukraine: Challenges Caused by Full-Scale Invasion into Ukraine" was launched to provide a comprehensive overview of statelessness in Ukraine.

Events:

- Consultations on the resolution of statelessness with the State Migration Service of Ukraine,
 Ministry of Justice, Ministry of Social Policy, State Service of National Statistics, and
 Ombudsman's Office. Participants discussed the relevance of the issue of statelessness, shared
 their experiences of working with stateless and undocumented persons and their own experiences
 in this area, and made recommendations for future research of statelessness issue in Ukraine;
- Training for representatives of the Ombudsman's Office on legal definition and regulation of statelessness in Ukraine;
- 2 webinars for lawyers of the Free Legal Aid Centers.

International representation:

- Keynote speech 7th Online Course on Statelessness (International Institute of Humanitarian Law, Sanremo, Italy) – March 2023

MISSION

The mission of the program after February 24, 2022 is to ensure:

- that Ukraine complies with its obligations in the field of international protection despite the state of war
- the authorities of the EU and Member States take into account the vulnerability of non-Ukrainian refugees when making decisions about temporary protection

NATIONAL ACTIVITIES

National advocacy:

R2P faced gross violations of refugee rights in Ukraine and the authorities' unwillingness to conduct a dialogue on this topic. Therefore, R2P united the efforts of civil society organisations to make the problem visible and find its solution.

National research:

INTERNATIONAL ACTIVITIES

International advocacy:
